Open Gun Dog open to Brittany's Only. All other stakes open to all registerable pointing breeds, Open Puppy, Open Derby, Open All Age, Amateur Gun Dog, Amateur All Age, and Amateur Walking Derby. Bitches in season may only compete in the last brace of the day on the course used. Entries limited to a maximum of 13 braces per stake. Entries will close when the limit is reached. This could occur prior to the specified closing date. We reserve the right to cancel any stake with fewer than 8 entries. Entries will be accepted no sooner than 30 days prior to the first day of the Field Trial (march 20 2018). Entries will be accepted by hand delivered, e-mail or mail. Entries will be applied in the order they are opened. This trial will be run under AKC's flexible format and held under the rules and procedures of the

Chuckar and/or quail and or /pheasant will be released in all stakes except The open puppy stakes. A blank cartridge will be fired in all stakes except open puppy, Horseback handling be permitted in all stakes except, amateur walking derby

Only AKC approved tracking collars will be permitted.

Prizes - Standard AKC Rosettes to all placed dogs

The fine print: All participants, guests and entries are accepted on the strict condition that the Washington Brittany Club, its officers, officials, members and committee are released from liability for any and all loss, damage or injury sustained by people, dogs, horses, vehicles, or any other sort of liability in connection with or during the trial from the time the participants or guests arrive at the trial grounds.

Only certified weed free hay allowed on BLM Grounds!

Bring your own or arrange with the supplier (John Henderson) or pre-order through Kris (the trial secretary). The club will have hay delivered for sale to the site prior to the trial

Absolutely no dumping of horse manure is allowed on the grounds.

All horse manure must be put in a designated trailer/truck that will be on site. All horse manure will be hauled off to a different location. All horse and dog manure needs to be transported to the designated vehicle. No trash may be mixed with manure as the manure will be spread on fields. The Brittany clubs continued use of these grounds depends on our total compliance in this issue.

Due to possibility of igniting a wildfire Absolutely NO SMOKING on course or outside of your vehicles. Only permitted vehicles allowed to drive on any course.

Limited Water will be available on course. **Handlers should be prepared to carry appropriate water for their dog and horse.**

WBC Emergency Disaster Plan available at the Secretary's table. Please check in with the Secretary for questions, changes or concerns. Thank you for your support of the Washington Brittany Club.

From East: Take I-90 Exit #231 toward Tokio Weigh Station onto Danekas Rd/N. Durry Rd. Turn right on N. Hills Rd. which becomes Harrington/Tokio Rd. Continue six miles. Cross bridge over Crab Creek and turn left, go thru the gate into camping area of Goose Butte Mgmt. Unit. Please re-close the gate

From West: Take I-90 Exit #226 and turn left on E. Schoessler Rd. over I-90 to T intersection. Turn right on Danekas Rd. to Harrington/Tokio Rd. then turn left N. on Hills Rd. which becomes Harrington/Tokio Rd. Continue six miles. Cross bridge over Crab Creek, then turn left, go thru the gate into camping area of Goose Butte Mgmt. Unit. Please re-close the gate

GROUNDS: Overnight camping is permitted. No open fires allowed on the grounds. Camping is confined to the designated parking area. Water will be available for animals. Please bring your own drinking water. Please clean up your area of all horse manure and, spread the remaining hay, fill in holes you dogs may have dug, and remove trash before you leave. Future access to these grounds are impacted by the state in which the grounds are left.
